***We want to make our relationship successful, so here are some things you need to know about having a credit account with the Pitkin County Solid Waste Center:***

- When your driver presents a load we will require that a job name be given in order to process the ticket. Please make sure your driver is aware of the project name. We supply ID cards that should be given to your drivers to authorize charges to your account.
- Please have the load uncovered and available for inspection before coming into the Gate House.
- The speed limit up and down the entry road, as well as throughout the landfill, is 15 mph. Please keep it slow as the roads change continuously, there is a large volume of traffic in the facility and construction vehicles are continually in use.
- We send out statements on the 5<sup>th</sup> of the month for the entire previous month's invoices/tickets. Payment is due on the 20<sup>th</sup>. (Ex: All February invoices/tickets will be billed and mailed on one statement by March 5<sup>th</sup> and payment is due in full by March 20<sup>th</sup>).
- Please let us know immediately if you find any errors or discrepancies on your statement. We want to make sure it is correct and that you understand your statement. Please call 429-2883 with any questions, or fax us at 923-2043 and let us know what the error is in regards to. You do not have to pay the amount in question while we sort it out, but you are still obligated to pay the amounts that are not in question.

***By application for a charge account and signature below, the applicant agrees as follows:***

- To pay for charges incurred at the Pitkin County Solid Waste Center by the applicant and its authorized personnel.
- To pay late fees on past due amounts.
- The account will be closed if any balance goes beyond sixty (60) days. Balance must be paid in FULL before account will be re-opened.
- To pay for the attorney's fees and/or collection agency fees necessary to collect past due amounts from the applicant.
- To pay a twenty dollar (\$20) service charge on any checks returned for insufficient funds.
